

Senior Lecturer in Dietetics and Human Nutrition - School of Health, Social Work and Sport - Grade I

Job Description

Purpose

To act as course lead and support curriculum development of a 2-year pre-registration MSc Dietetics programme.

To support all aspects of teaching, learning, and assessment of modules within the subject areas of Dietetics and Human Nutrition.

To provide high-quality educational opportunities where students are facilitated to learn about the role and skills of Dietitians to achieve both academic qualification and professional recognition.

To contribute to the activities of the school, and University concerning i) teaching, learning, and assessment, ii) research and development, and iii) consultancy and other commercial activity.

Duties

- 1. Deliver the learning, teaching, and assessment of modules allied to undergraduate and postgraduate courses within the school.
- 2. Act as a course leader and contribute to the management, administration, and development of Dietetics programmes within the school.
- 3. To carry out research, consultancy, and professional activity.
- 4. Act as a module leader for a number of identified modules.
- 5. Develop innovative and engaging teaching materials.
- 6. Contribute to the ongoing development of programmes and modules within the school, including the creation of module information packs, assessments, and examination questions.
- 7. Adhere to quality assurance and enhancement systems to ensure high standards are maintained and the student experience is enhanced.
- 8. Attend local and national events on behalf of the University, to promote the University and its courses, and to enhance the institutional, School and Team profile.
- 9. To act as personal tutor for students.
- 10. Undertake any additional relevant duties as agreed with the Associate Dean of the School.
