Job Description

Purpose

To contribute to the quality assurance for practice learning for learners on nursing programmes within the School of Nursing and Midwifery.

Duties

- 3. To contribute to achieving the academic objectives in the school through teaching, research, and income generating activities.
- 4. To undertake administrative duties relevant to the support of learners on nursing programmes).
- 5. Engagement with relevant external organisations to enhance the learning and assessment of learners on NMC approved programmes in practice including undertaking of educational audits and supporting the preparation of Academic Assessor, Practice Assessors/Supervisors.
- 6. To engage with the recruitment of students onto courses and to provide appropriate advice on progression and career opportunities.
- 7. To adhere to quality assurance and enhancement systems to ensure high standards are maintained and the learner experience is enhanced.
- 8. To contribute to the delivery of the school's commercial activities, including training, and funded projects.
- To undertake any duties relevant to the school's activities and commensurate with the level of the post, as directed by the Dean of School and/or the nominated Line Manager
