

Clinical Senior Lecturer in Medicine - School of Medicine and Dentistry - Grade Clinical Senior Lecturer

Job Description

Purpose

This post sits within the clinical years of the MBBS course.

With the support of the Module Lead and Theme Lead for Medicine in Clinical Practice, the postholder will lead on delivery of the programme for Year 4 MBBS students who are undertaking an additional year of studies to repeat the Applied Knowledge Test component of the Medical Licensing Assessment.

The postholder will also assist as required with teaching and assessment for other student cohorts within the clinical years.

The post is based at the University's Burnley campus, with occasional travel to the University's Preston and Westlakes campuses.

Duties

1. Lead on the delivery of the programme for the Year 4 AKT repeat students in line with the module descriptors, including adaptation of existing materials and facilitation of teaching sessions.
2. Analyse student performance to enable delivery of an evolving programme tailored to the students' learning needs.
3. Develop new curriculum materials and resources to support delivery.
4. Liaise with staff from the other Year 4 modules to ensure the programme is comprehensive and all relevant elements are included.
5. Work with staff from the administrative, timetabling and placement teams to ensure a detailed timetable is created and provided to students in a timely manner, integrating both the campus and placement components of the programme.
6. Act as Academic Advisor / Portfolio Tutor for this cohort.
7. Monitor and support students with issues with attendance or academic performance, liaising with the Module Lead, Theme Lead and Student Achievement Coach.
8. Maintain the student Blackboard space for the module, ensuring this contains comprehensive materials and is kept up to date.
9. Assist with creation of the formative and summative written assessments for MICP including item writing, blueprinting, item selection, standard setting, and quality assurance.
10. Contribute to teaching and assessment across other areas of the MBBS clinical years programme as required.
11. Take responsibility for the necessary academic administration.
12. Evaluate the programme to provide data to the relevant stakeholders and respond to student feedback.
13. Assist with OSCE station writing, OSCE examining, and invigilation as required.
14. Participate in the student admission process: open days, outreach, recruitment, and selection events.

15. Undertake any other duties relevant to the School's activities and commensurate with the level of the post, as directed by the Director or Deputy Director of Clinical Studies or Dean of School.
16. Make a contribution to achieving the academic objectives in the School through teaching, research, and income generating activities.
