Job Description

Purpose

The postholder will lead on the provision of professional leadership and management of the Clinical Dental Technology and Dental Technology courses and will also be expected to liaise with the leads of other professionally regulated courses to deliver an integrated approach to dental teaching.

Duties

- To undertake the leadership and management of the Clinical Dental Technology and Dental Technology courses.
- 2. Ensure the achievement of excellence standards, for both the student and staff experience.
- 3. Assist the Head of Dentistry in the achievement of strategic objectives in the School, the wider University and external environment.
- 4. Provide oversight of staff involved in teaching, supervision and assessment of students across all placement locations.
- 5. Effectively collaborate with strategic partners in the advancement and delivery of dental training.
- 6. Assist with the overall academic leadership within the School, ensuring the quality of teaching and learning, and assessment.
- 7. Help to promote the research and knowledge transfer agendas within the School using evidence-based approach.
- 8. Oversee student recruitment and retention.
- 9. Undertake appraisals, recruitment, retention and development of designated staff.
- 10. Assist the Head of Dentistry in assisting in the provision of assurance regarding professional body requirements.
- 11. With regards to the nature of your role and its impact upon our students, make an active contribution to and support the improvement of the student experience.
- 12. Undertake other relevant duties and responsibilities appropriate to the grade of the post which may be assigned by the Head of Dentistry or Dean of Medicine & Dentistry.
